You may not “sell” your clinic reservation to another person without permission from the clinic organizer.

This clinic has an indoor option – so we are a go rain or shine!! Everyone will be notified the night before if we are going to be in the indoor.

Attire: Riders will all be required to wear ASTM approved riding helmets and riding boots at all times while mounted.

Cost: \$275 per rider – includes auditing for one additional person.
Groups will be capped at 8 riders per session. Spots will be assigned on a first come, first served basis by completed entry and payment.
